Quotes and Purchase Orders:

To obtain a quote, contact your local John Deere Dealer.

All purchase orders must show Deere & Company as the vendor and reference the contract number.

Purchase orders must be generated by the <u>Texas SmartBuy (TSB) system</u>. Only purchase orders issued through the TSB system are eligible for contract pricing. POs issued by the TSB system will have the State of Texas logo at the top and will be signed by Bobby Pounds as shown <u>here</u>. The agency should generate the PO and provide it to the dealer. The John Deere Dealer will submit the purchase order to John Deere's Government Sales office.

Contract Details

Quotes	Quotes are valid for 30 days from the creation date of the quote OR until the contract expires, whichever occurs first. All quotes created in JDQ2 have creation and expiration dates on the upper right hand corner of the first quote page for your convenience.		
Allied - Non- John Deere Equipment	Allowed with restrictions as long as the Allied equipment is compatible with the contract equipment being purchased. Allied equipment/items cannot total more than \$5000. Items must be clearly labeled on the purchase order as "open market".		
	Allied equipment includes implements, attachments, accessories, bundles, extended warranties or parts requested by the customer to complete the equipment purchase.		



Credit Cards	Not allowed on this contract.			
Demo	Allowed if the machine does not exceed the hour usage for new warranty as outlined in the Warranty Administration Manual.			
Fees	Delivery Charge Optional delivery charge of \$8.00 per loaded mile is allowed for the delivering dealer. Use Goo Maps to calculate the mileage.			
	This fee is <u>not</u> per machine; it's per load. This fee should be shown separately on the quote or purchase order. Miles are to be calculated using Google Maps.			
Financing	Not allowed on this contract.			
Leasing	Not allowed on this contract.			
Multiple Unit Discount	Multiple unit discounts are permitted. The contract discount plus the multiple unit discount equals the total discount. Discounts are based on the following schedule:

Non-contract equipment/items cannot total more than \$5000, or 50% of the total PO value, whichever is lesser. Items must be clearly labeled on the purchase order as "open market/incidental".			
	Non-contract Deere equipment includes implements, attachments, accessories, bundles, parts, extended warranties, Frontier (when not a part of the contract) and Order Zone items requested by the customer to complete the equipment purchase.
