Quotes are valid for 30 days from the creation date of the quote **OR** until the contract expires, whichever occurs first.

To obtain a quote, contact your local John Deere Dealer. Submit your purchase order to your dealer. The John Deere Dealer will submit the purchase order to John Deere's Government Sales office.

All purchase orders must show Deere & Company as the vendor and reference the contract number.

Contract Details

Delivery Obligation	Optional delivery fee of \$8.00 per loaded mile is allowed for the delivering dealer. This fee is not per machine; it's per load. Use Google Maps to calculate the mileage. The fee should be shown as a separate line item on the quote and/or the purchase order.
Fees	Utah Contract Allows Set Up to be charged to the agency on the quote and PO. Fees must be clearly labeled on the quote or purchase order.
Financing	Allowed: If the agency rule and guidelines allow.
Manuals	An operator's manual is included with the delivery of the equipment at no charge.
Multiple Unit Discount	Sales of 3 or more like self-propelled products sold on the same purchase order are eligible for the multiunit discount. The 3 or more self-propelled products must be in the same equipment categories as shown below and included on the same purchase order. Compatible implements and attachments sold with such products also qualify for the multi-unit discount, but do not count as a unit. Frontier Equipment is excluded from the Multiple Unit Discount.
